

## **STUDIES IN DEVELOPMENT**

- AutoBOOST – This study plans to look at cardiac waveform data in TBI, examining changes in auto-regulation and will use data that is already collected by Moberg. NOA was received on 5/24 – more coming soon!
- PS-ECMO – practice patterns in ED ECPR. In conceptual design phase and looking into a prehospital bundle to drive ECPR. Survey link and info above!
