Recertification/Relicensure surveys occur every 3-5 years

- 2022 – 2 surveys
- 2023 – 2 Surveys
- 2024 – 2 surveys (1 facility subsequently deemed)

Survey Process Updates

Surveys include on-site and remote components

- Survey initiated on-site
- Surveyor will discuss ways to share patient records at entrance conference. Opportunities to provide additional information, ask questions via email, phone, Teams.
- Exit conference may be held via Teams. Surveyor will schedule with Administrator. Administrator will be able to forward invite for others to attend.

Oregon Hospital Staffing Law Clarifications


- NSC, NSPs, PTSCs, PTSPs, SSCs & SSPs
- Ratios & Enforceable Language – OHA can only enforce what is written in the NSP.

Oregon Hospital Staffing Law Clarifications

- Variances for Type A & B Hospitals
 - Described in ORS 441.763(6)
 - Permits variance from the unit-based nurse staffing ratio requirements in ORS 441.765
 - Only available to Type A & Type B hospitals
- Waivers – ORS 441.778

Oregon Hospital Staffing Law Clarifications

Neither a Variance nor a Waiver can relieve Hospitals from

- The requirement to have a staffing committee
- The requirement to have and comply with a staffing plan
- The requirement to release staffing committee members to attend staffing committee meeting
- The maximum patient limits for CNAs in ORS 441.768
- Mandatory Overtime (MOT) limitations for Nursing Staff Members
- BOLI's meal & break requirements

Maternity Services

- General Acute Care Hospitals in Oregon are required to provide maternity services under OAR 333-500-0032(2)(a) unless they have an approved waiver under OAR 333-500-0065.
- Critical Access Hospitals are not required to have a maternity unit.
- All Oregon hospitals must comply with the federal Emergency Treatment and Active Labor Act (EMTALA). Hospital with an ED must “provide necessary stabilizing treatment to an individual with an EMC or an individual in labor” regardless of whether the hospital offers maternity services.
